Dear Mr. Pierson:

The Town of Addison's Interim Outfall Sewer Agreement with Farmers Branch providing for unmetered sewer flows through the Farmers Branch system to the Trinity River Authority (TRA) treatment facility expired in 1993. Addison currently maintains one such unmetered sewer line access point and has been compensating Farmers Branch based on provisions of the expired agreement. In order to control rising TRA costs and ensure compliance with state and federal regulations, Addison will be required within the next two months (May 25th deadline) to either divert this flow or install a TRA deduct meter. The line will be capped after this deadline should either of these conditions not be met in order to ensure the integrity of the City's sanitary sewer system.

Farmers Branch will begin notifying businesses (along 4568-4580 Belt Line Rd. and 15000 block of Beltwood Pkwy.) of possible future service interruption at noon on Wednesday, March 28th.
