The City of Farmers Branch has reviewed Addison's request to participate in the reconstruction of Midway Road. The City owns one lane of Midway Road from Spring Valley north to the city limits line or approximately 4,150 linear feet. The estimated reconstruction cost for this lane is \$500,000.

Unfortunately, the City must deny this request as this lane of Midway Road does not meet the reconstruction priority levels of other streets in the City. Additionally, resources are limited due to \$635,000 in legal and engineering bills related to protecting Farmers Branch Creek.
