Council Updates

Sherlock Drive To Get Storm Drain Improvements

During rain events in 2015 and 2016, the area around the intersection of Winter Park Lane and Sherlock Drive experienced flooding that caused damage to one property and threatened others. At the time, Halff Associates, Inc. was under contract with the Town to develop the Town's stormwater master drainage study, so staff asked them to analyze the causes and provide alternatives for reducing the flooding in that area. The analysis showed that the intersection of the two streets is located in the lowest elevation portion of that area and is the collection point for 23 acres in that neighborhood.

Council evaluated several alternatives in June 2017 and authorized the staff to move forward with a plan that would increase the size of the existing storm drain system in the area.

At the June 26 meeting, Council approved a contract with FNH for \$1.3 million to replace and upsize the existing storm drain piping from the intersection of Sherlock Drive and Winter Park Lane to Belt Line Road, install several new inlets at the intersection of Sherlock Drive and Winter Park Lane, and reconstruct that intersection. The project, which unfortunately exceeded the engineer's estimate, will be funded through the Storm Water Capital Improvement Program.

Council Gets NTECC Update

In January 2014, Addison joined the cities of Carrollton, Coppell, and Farmers Branch in establishing a Local Government Corporation to create the North Texas Emergency Communications Center (NTECC). NTECC is a regional public safety communications center that provides consolidated Police, Fire, and EMS dispatch services to a resident population of approximately 220,000. Terry Goswick, Executive Director of NTECC, presented Council with a brief overview of the center and its operations during a work session on June 26.

Council Amends Sign Ordinance to Allow Flags and Bunting and Approves Agreement to Review Current Development Regulations

In response to community concerns, Council voted to amend the current Sign Code to remove limitations on the number of flags that may be displayed on any property for the time period ranging from the five days prior to any national holiday through three days after the holiday. Additionally, the definition of a "flag" has been expanded to include any fabric or bunting containing distinctive colors, patterns, symbols or graphic depictions. It does not, however, include text.

Prior to Tuesday night's meeting, Addison's Sign Code limited properties to display a maximum of three flags that could either be the United States, Texas, or Addison flags. Additionally, the Code limited the size of the flags to no more than 40 square feet and required they be on a flagpole of no more than 30 feet. All other types of flags were considered signs and not allowed. No other types of patriotic displays were allowed because they were considered to be either portable, moving, banner, or flag signs, which were all prohibited.

Also at the meeting on Tuesday, Council approved an agreement with Clarion Associates to review all of the Town's current development regulations, which will include the Sign Code. This process is anticipated to take two years to complete, so the revised amendment is a temporary fix until that assessment is adopted.

Municipal Code Corporation Selected for Website Redesign

Council approved a contract at the June 26 Meeting with Municipal Code Corporation to redesign the Town's website and microsites. The Town received 18 proposals for the project. The goal of the new website is to make it more user-friendly and visually appealing, address cybersecurity issues, and compliance with ADA requirements. There will be opportunities for community input during the six-month redesign process.

AFD Achieves Class 1 ISO Rating

Addison Fire Chief David Jones announced at the June 26 City Council Meeting that the Addison Fire Department has received the highest Public Protection Classification (PPC) rating awarded by the Insurance Services Office (ISO) and approved by the Texas Department of Insurance. Addison joins only 63 communities in Texas in achieving this prestigious Class 1 rating. There are only 305 Class 1 ratings nationwide.

ISO has surveyed over 49,000 communities nationwide and classifies each on a scale from one to ten. Communities with the very best systems for water distribution, fire department equipment, and firefighting personnel, as well as fire alarm facilities, receive a rating of 1. A PPC rating has a direct bearing on the cost of property insurance for homes and business in the community. Ultimately, this recognition of Addison's outstanding fire protection not only means better fire protection, but also lower property insurance rates. The effective date of the new classification is August 1, 2018.


