Council Update

Council Discusses Regulations for Temporary Directional Signage

At its October 8 work session, Council discussed the Town's regulations for temporary directional signage. Examples of temporary directional signage are garage sale, yard sale, estate sale, real estate and open house signage. The Town will be evaluating its policies regulating temporary signs as part of the Unified Development Code (UDC) update. According to the current UDC timeline, signs are scheduled to be reviewed in May 2020. Council directed staff to discuss with the consultant the impact of expediting that discussion.

Council Adopts Investment Policy for Fiscal Year 2020

The Public Funds Investment Act (PFIA) requires the Council to annually adopt the Town's Investment Policy. Finance staff, along with the Town's investment adviser, Hilltop Securities, determined that minor changes to the existing policy were needed. Chief Financial Officer Olivia Riley shared those changes with Council at its October 8 meeting.

Direct management responsibility for the investment program is delegated by the City Council to the Chief Financial Officer. The investment policy that Council adopted on October 8 has the following priorities:

- Understanding the suitability of the investment to the financial requirements of the Town
- Preservation and safety of principal
- · Liquidity
- Marketability of the investment if the need arises to liquidate the investment prior to maturity
- · Diversification of the investment portfolio
- Yield

Council Adopts Special Events Strategic Plan

At its October 8 meeting, Council adopted a five-year Special Events Strategic plan that was developed by Strategic Event Initiatives in conjunction with staff from the Special Events, Marketing and Communications, and Economic Development and Tourism departments.


- 1. Enhancing event products and calendar


