## **Council Updates**

## Council Adopts Pilot Program to Establish Regulations for Short-Term Rentals

At its March 12 meeting, the City Council amended Addison's Code of Ordinances in order to establish regulations for short-term rentals. Given the popularity of apps such as Airbnb, the use of short-term rentals in residential areas, including Addison, has increased.

The new ordinance requires property owners offering short-term rentals to register with the Town. Registration would be good for a period of one year and costs \$25. Additionally, the ordinance would impose certain operational standards including prohibiting the renting of a home as a party venue. The property owner would be required to provide renters with their contact information, as well as pertinent information regarding local rules and requirements for things such as parking, noise, and trash collection.

The Town would be required to send notice to properties within 200 feet of the short-term rental property. This notice would provide adjacent property owners with information about the ordinance requirements, as well as a 24-hour complaint line, which would be the Town's non-emergency dispatch number.

Lastly, the ordinance amends the definition of a hotel to include short-term rentals. This change allows the Town to collect hotel taxes from short-term rentals.

The ordinance, which will go into effect on May 1, includes a sunset provision after one year, requiring the City Council to review and adjust or extend these requirements by April 30, 2020. The Town will be sending out additional information about how to register a property as a short-term rental in the near future.

#### **Council Discusses Permitting Personal Transportation Vehicles**

During a Work Session on November 27, 2018, the City Council discussed potential regulations for bike-sharing and scooter-sharing companies operating in the Right-of-Way and on Town properties such as parks and trails. Based on the discussion, Council directed staff to develop a pilot program with similar requirements to those currently being utilized by the City of Plano.

Staff presented a draft <u>ordinance</u> to Council during the March 12 Council Work Session that would group bicycles, scooters and similar vehicles under a new term called "Personal Transport Vehicles" (PTVs). The ordinance would require that any company who wants to offer PTVs for rent in Addison obtain a <u>permit</u>. The permit would require the PTV rental company to agree to a number of requirements regarding the maintenance and upkeep of PTVs, as well as the placement and parking of PTVs.

Council provided feedback on the pilot program that would end on December 31, 2019. Staff will incorporate those changes and bring the item back for discussion and possible action at a future meeting.

#### **Council Accepts Fiscal Year 2018 CAFR Report**

The Addison Town Charter requires that the Town staff prepare a Comprehensive Annual Financial Report (CAFR) which shows the status of the Town's finances. The charter also requires that the Town's financial statements be audited annually by an independent external auditing firm. The results of the independent external audit are included in the Fiscal Year 2018 CAFR. On March 12, Addison's auditors BDK, LLP, an independent firm of licensed certified public accountants, shared with Council that it has issued an unmodified option, which means that the financial statements are presented, in all material respects, in accordance with applicable financial reporting framework. Simply stated, an unmodified opinion is a clean opinion.

As part of their presentation, the auditors highlighted that Addison's pension plan is 100% funded. You can watch the Council discussion on the CAFR here.

Addison Announces the Appointment of a New Deputy City Manager



Addison City Manager Wes Pierson announced on Tuesday, March 12 the appointment of John Crawford to serve as Addison's new Deputy City Manager. John is currently the Director of Public Works for the City of Carrollton and will assume his role in Addison on March 25. With help from Strategic Government Resources (SGR), Addison conducted a national search to fill the position. John will be joining Deputy City Manager Ashley Mitchell to complete the executive management team.

As the Director of Public Works in Carrollton, John operates a competitive business unit, benchmarked with public and private operations, comprised of 126 employees, and manages a \$44 million operating budget and a \$71 million capital budget. He is accountable for streets, water distribution, wastewater, drainage, and meter services divided between two divisions and eight sections. Prior to his role as Director of Public Works, John served as the Intelligence Division Commander for the Carrollton Police Department where he was responsible for the Covert and Street Intelligence Units, School Resource Officers, and the Crime Analysis Section.
