# **Council Update**

Council Discusses Census Count Committee and Approves Funding to **Support Dallas County 2020 Census Participation Initiative** 

Senior Planner Olga Chernomorets gave Council a presentation at its September 24 work session on the 2020 Census. The United States Census Bureau conducts a nationwide population count every ten years as required by the U.S. Constitution and will attempt to contact every household in the country in the spring of 2020. Accurate census counts are important to Addison in the following ways:

- Population counts determine the distribution of federal representatives in Congress.
- The census count guides federal funding dispersal of \$675 billion to states and cities annually.
- Local governments use the census for public safety and emergency preparedness.
- Land developers use census data to build homes and revitalize communities.
- Business and industries use data to decide where to build or relocate, creating employment opportunities.
- Residents use the census to support community initiatives involving legislation, quality of life, and consumer advocacy.

An important component of insuring accurate census counts is through education and outreach motivating the population to participate. In an effort to promote participation, the U.S. Census Bureau encourages the creation of local Complete Count Committees. A Complete Count Committee would be comprised of a broad spectrum of members with the goal of maximizing participation in the Census. Complete Count Committees encourage resident participation in the Census through the utilization of local knowledge, influence, and resources to educate and promote the Census through local-based outreach efforts. Additionally during its regular September 24 meeting, Council approved an interlocal agreement for \$5,000 with Dallas County for the Regional Census Fund. Dallas County has asked local municipalities to partner with them to seek a qualified vendor to coordinate the 2020 Census Participation Initiative in an effort to increase census response rates across the county. The selected vendor will coordinate efforts and activities with the Addison Complete Count Committee.

#### **Council Discusses Rules for Public Comments During Open Meetings**

House Bill 2840, which became law on September 1, 2019, created a right for members of the public to address the City Council at an open meeting of the Council before or during Council action on an item. At Council's September 24 work session, staff briefed the Council on the law and discussed the Town's rules regarding public comments at open meetings. Currently, there is time dedicated to public comments at the beginning of each regular Council meeting, however, comments are limited to items not on the agenda unless the item is posted as a public hearing. This bill allows the community to comment on any item, even those posted on the agenda, during the dedicated public comment time.

### **Council Amends Fiscal Year 2019 Budget**

Each year, the Finance staff reviews the budget to determine which items should be recognized with formal budget amendments. When budget variances occur that are outside the authority of the City Manager, these adjustments are presented to the Council in the form of a budget amendment. Council approved three amendments to the Fiscal Year 2019 budget at its September 24 meeting.

Major items included:

#### General Fund

- The first amendment moved funding from the General Fund fund balance into the Parks Department budget to cover the costs of the June 2019 storm cleanup in the amount of \$235,000.
- The second amendment added funding to the Finance Department for payment to the Town's sales tax audit firm for audit collections. This payment in the amount of \$305,000 can be funded from the increase in sales tax collections with no impact to the General Fund balance.

#### Hotel Fund

 An amendment was needed for the Addison Theatre Centre in the Hotel Fund. Insurance proceeds in the amount of \$12,880 have been received for an accident that resulted in equipment damage. This amendment added funding to cover the costs of replacing the damaged equipment.



### **Unified Development Code Community Meeting**



Addison is in the process of a comprehensive review of the Town's development regulations. Many of the Town's rules for development were crafted in the 1980s and may not be keeping up with current development trends, shifting demographics, and evolving consumer preferences or current and future community needs. To accomplish this review, the Town is working with consulting firm, Clarion Associates. Clarion has completed a draft of Part 1 of 3 of the new Unified Development Code (UDC), which includes zoning districts, use regulations, and definitions sections, and would like the community's input.
