## **Council Update**

#### Council Gets Quarterly Financial Report for the Fiscal Year 2019 Third Quarter that Ended June 30, 2019

Addison's financial policies require the publication of a financial report 60 days subsequent to the end of each fiscal quarter. The financial and investment reports presented to Council at its August 27 meeting covered the financial performance for the third quarter for Fiscal Year 2019 (April 1, 2019 - June 30, 2019). <u>The financial report</u> includes information for the following funds: General, Hotel, Economic Development, Airport, Utility, and Stormwater.

Key highlights for the third quarter include:

- General Fund fiscal year-to-date revenue totaled \$34.4 million, which is 91.8 percent of the overall budget amount. Sales tax collections are 83 percent of the fiscal year 2019 budget. Expenditures for the various departments are in line with the FY2019 budget.
- Hotel occupancy tax collections are 65.5 percent of budget for eight months of collections or 66.7 percent of the fiscal year. Hotel fund expenditures total \$4.3 million or 47.7 percent of budget. Performing Arts expenditures are at 98% due to full payment of the WaterTower Theatre grant.
- Operating revenue in the Utility Fund through the third quarter totaled just over \$7.2 million or 56.5 percent of the fiscal year 2019 budget. With a one-month lag in the collection of utility revenues, eight months (66.7 percent) of the fiscal year have expired. Water revenues are 52.3 percent of the fiscal year 2019 budget, as a result

of unusually wet weather this spring. Operating expenses through the third quarter totaled approximately \$7.9 million, or 66 percent of the fiscal year 2019 budget. Wastewater treatment expenses, however, are unusually high due to the increased costs from the Trinity River Authority wastewater treatment.

• Operating revenue in the Stormwater Fund through the third quarter totaled \$1.6 million or 75% of the fiscal year 2019 budget. With a one-month lag in the collection of stormwater revenues, eight months (66.7 percent) of the fiscal year have expired. Operating expenses through the third quarter totaled almost \$1.2 million or 58 percent of the fiscal year 2019 budget.

The financial condition of the Town remains strong and all reported funds adhere to the 25% fund balance requirement and meet the Council's 30% goal. The <u>Third Quarter</u> <u>Investment Report</u> adheres to the Town's Investment Policy as adopted by Council and is in keeping with all State laws.

### **Council Approves Location for Two Public Art Pieces**



At its August 27 meeting, Council approved the locations of two new public art pieces proposed by the Addison Arbor Foundation (AAF). The first is a stainless steel sculpture by Art Fairchild called Tango Fantasia that will be located in the half circle drive in front of the Addison Conference and Theatre Centre. The sculpture finish will include a wire brushed texture and mirror finish and will be illuminated with color LED lights at night. The second piece is a powder coated steel and cable sculpture planned within the public art easement on the southeast side of the AMLI development near Addison Circle. The 18-foot-tall sculpture which has been named Spectra, will be created by artist Scott Shubin and be located on Spectrum Drive. #### **Council Gets Special Events Update**

Director of Special Events Jasmine Lee and Accounting Supervisor Ashley Boatright presented the marketing, operational, and financial outcomes for Taste Addison and Kaboom Town! to Council at its August 27 meeting. Taste Addison was the first Addison festival in 2019 to utilize point-of-sale software in place of the previous Tasty Bucks ticket system. The feedback from participating restaurants and attendees was positive. Taste Addison was impacted by rain on Saturday afternoon which affected attendance and revenue numbers. Event expenditures exceeded revenues by \$650,000, which was less than 1% over the amount budgeted. However, it generated more than 2.7 billion impressions through media buys, in-kind media sponsorships, and public relations efforts, and booked 155 hotel room nights. Kaboom Town! attracted 25,000 people to Addison Circle Park, but more than 500,000 to Addison, and generated 735 hotel room nights. In an event survey, 97% of attendees rated Kaboom Town! as above average or excellent. Event expenditures exceeded revenues by \$ 313,485, which was 25% under what was budgeted. Ms. Lee also shared a preview of Oktoberfest 2019. The event will take place from September 19 - 22 at Addison Circle Park. #### **Council Adopts Ordinance to Comply with House Bill 3167**

House Bill 3167, which became effective on September 1, 2019, prescribes the process by which municipalities and counties must review and act on plats. Under the provisions of the Bill, cities must act to either approve, approve with conditions, or deny a plat within 30 days of receiving a complete submittal. If approved conditionally or if denied, the Town must provide either the conditions or specific reasons for denial in writing. This is already the Town's current process and should not have any effect on the Town's review.

The Bill also states that the applicant requesting the plat has an unlimited amount of time to respond to the conditions or reasons for denial. Once they resubmit a plat that addresses any outstanding issues, the Town must act within 15 days. Since the Planning and Zoning Commission reviews plats and only meets once a month, this means that the Town may need to call special P&Z meetings to consider plats in order to comply with this new timeline.

Council approved an ordinance at its August 27 meeting that directs Staff to process plats in accordance with the timelines and processes established in House Bill 3167. As Town staff continues the Unified Development Code update, it will amend the Town's subdivision regulations to mirror the Bill's requirements as well.

#### **Upcoming Public Hearings**

On September 3, the Council held its second public hearing on the Fiscal Year (FY) 2020 tax rate and its first public hearing on the FY2020 budget. A second public hearing on the FY2020 budget will be held during the regular Council meeting scheduled for Tuesday, September 10, 2019. The meeting will begin at 7:30pm and be held at Addison Town Hall. The <u>agenda will be posted here three</u> days prior to the meeting.
