Council Update

Mask Mandate Update

Addison is continuing to monitor the changing and ongoing legal conflict regarding the Dallas County mask mandate. Once it has reached its final conclusion, we are prepared to respond accordingly.

The health of our community continues to be a top priority, so in the meantime, we are encouraging members of the public to wear masks as they deem appropriate, wash hands or use hand sanitizer frequently, practice social distancing as necessary, and stay home when sick. Council Makes Board and Commission Appointments

The City Council made appointments to the Planning and Zoning Commission, Board of Zoning Adjustment, and Community Partners Bureau at its December 14 meeting.

Planning and Zoning Commission Appointments

The Planning and Zoning Commission members may serve up to three consecutive twoyear terms and has four members with terms expiring in December 2021. The next term of office begins in January of 2022 and expires in December of 2023. Bob Catalani (nominated by Council Member Braun), Chris DeFrancisco (nominated by Mayor Chow), and Tom Souers (nominated by Council Member Wheeler) were reappointed. Juli Branson (nominated by Council Member Ward) was appointed for her first term.

Board of Zoning Adjustment Appointments

The Board of Zoning Adjustment has four members with terms expiring this year. Individuals appointed to the Board may serve up to three consecutive two-year terms and will begin the next term in January of 2022. E.J. Copeland (nominated by Council Member Braun), Jeanne Dunlap (nominated by Council Member Ward), and Gary Krupkin (nominated by Mayor Chow) were reappointed. Precious Urenna Onyewuchi (nominated by Council Member Wheeler) was newly appointed.

Community Partners Bureau

The Community Partners Bureau is comprised of residents appointed by the Council to represent the Town of Addison with its Community Partners (non-profit organizations). Volunteers serve for three-year terms and the agency terms are staggered so not all the liaisons are replaced the same year. Suzy Oliver was reappointed to serve as the liaison for Woven Health Clinic and Karen Perry was reappointed to serve as the liaison for the Dallas Cat Lady. Gail LeVine was selected to serve an unexpired term for The Family Place to replace a resident who has moved.

New Residential Development Planned for Vitruvian





At its December 14 meeting, the City Council approved an amendment to the Vitruvian Park concept plan to allow for rental townhomes at the southeast corner of Spring Valley Road and Vitruvian Way. This is a lower density option from the original plan that called for a 368-unit apartment complex in this location.

Council also approved the development plan which includes 85 three-story multifamily units, designed in a townhome form, and an amenity area near the center of the site. The unit mix ranges from one to three bedrooms units with an average unit size of 1,927 square feet. A two-car garage is provided for each unit at the ground level. The plan includes an eight-foot trail on the east side of the site in accordance with the Town's Master Trails Plan as well as an improved streetscape on Bella Lane, to include a six-foot trail.

New Daycare Planned for Spring Valley and Marsh

Council approved a Special Use Permit at its December 14 meeting paving the way for Tierra Encantada Spanish Immersion Childcare & Preschool to take the space at Spring Valley Lane and Marsh Lane previously occupied by Brilliance Pre-School and an adult ELS Language Center. Catering to children 6 weeks to 6 years of age, Tierra Encantada's curriculum is focused on bilingual education that fosters early cognitive development and diversity.

The floor plan of the renovated facility accommodates ten classrooms and includes an indoor playroom, kitchen, administrative offices, and a breakroom. It is anticipated that the center will house a maximum of 153 students and 27 staff members. There are two outdoor playground areas on the north side and west side of the building that will be resurfaced and playground equipment will be added.

New Restaurant Plans Move into Former Public School 972 Space

At its December 14 meeting, the Council approved a Special Use Permit for TK's Place, a new restaurant concept offering a comedic flair. Occupying the former Public School 972 space on Montfort Drive, TK's Place combines the owner's passions of food, hospitality, and comedy. The owners, TK and Kara Matteson, produced and performed stand-up comedy shows including performances on American's Got Talent and Comedy Central. They plan to offer both a lunch and dinner menu, but also offer comedy shows in a separate part of the restaurant for those who are interested in dinner and a show.


Council Discusses Commercial Vehicle Parking in Residential Areas

Commercial parking complaints, especially within Addison's multifamily residential areas, have become a more frequent FixIT app request to the Town. During the December 14 Council Meeting, Police Chief Paul Spencer shared some suggested amendments to the Town's current regulations addressing commercial vehicle parking in residential areas. The existing ordinance has conflicting language which calls out general residential land uses versus specific zoning districts, like urban centers, mixed-use developments, or planned developments. Also, the zoning language does not support the enforcement needs of the Police Department.

The current ordinance states that any commercial vehicle with a manufacturer's rated capacity in excess of three-fourths ton is considered a violation. Council discussed increasing that capacity to one ton. They will consider action on changes to ordinance Sec. 78-175 at a future meeting.

Moore Iacofano Goltsman Selected to Develop Conceptual Design of the Beltway Drive Trail Project



The City-Wide Trails Master Plan (CWTMP) was adopted by Council on May 25, 2021. The development of a trail system along Beltway Drive between Marsh Lane and Belt Line Road is included in the Plan's Phase I recommendations which are slated to be completed within the first five years of the date of adoption. At its December 14 meeting, the Council approved a contract with Moore Iacofano Goltsman (MIG) to complete a conceptual design of the Beltway Drive Trail Project. MIG's proposal includes public engagement strategies, including public feedback opportunities, and cost estimating in addition to the development of the conceptual design for the project.

The CWTMP recommendations for the Beltway Drive Trail Project were based on community input which indicated a need for bike lanes, improved internal circulation in neighborhoods, and a strong desire to make neighborhood connections to regional trails. The CWTMP recommends the following trail improvements along Beltway Drive:

- Buffered Bike Lanes between Marsh Lane and Midway Road.
- Bike Boulevard between Midway Road and Belt Line Road.
- Wide Sidewalk with Buffer from the Redding Trail heading east to Belt Line Road.

In addition to the proposed trail improvements for Beltway Drive, the CWTMP also recommends the development of Trail Signage and Wayfinding Standards. Once developed, the Trail Signage Wayfinding Standards will also be applied to all future trail signage projects. The project includes Linear Open Space Planning of the area south of Addison Grove, often referred to as Sam's Park, to improve connectivity and to refresh the green space. Other tasks in the project will be to establish what portions of the existing sidewalk should remain and be integrated into the trail system and what portions should be removed and replaced to meet the trail typologies defined in the CWTMP.

The funding for the conceptual plan is included in the FY2022 budget. However, funds have not yet been identified to implement the improvements identified in MIG's conceptual plan.

Addison Opts to Participate in State's Opioid Litigation Settlement

After years of negotiations, two proposed nationwide settlement agreements have been reached which would resolve all opioid litigation brought by states and local governments against the three largest pharmaceutical distributors, McKesson, Cardinal Health, and AmerisourceBergen, and one manufacturer, Janssen Pharmaceuticals, Inc., and its parent company Johnson & Johnson.

The proposed settlements require the companies to pay billions of dollars to abate the opioid epidemic. Specifically, the settlements require the distributors to pay up to \$21 billion over 18 years and Janssen to pay up to \$5 billion over no more than nine years, for a total of \$26 billion. Of the settlement amount, approximately \$22.7 billion is earmarked for use by participating states and political subdivisions to remediate and abate the impacts of the opioid crisis. The settlements also contain injunctive relief provisions governing the opioid marketing, sale, and distribution practices at the heart of the states' and subdivisions' lawsuits and further require the Distributors to implement additional safeguards to prevent diversion of prescription opioids.

At its December meeting, the City Council approved a resolution that confirms the Town's participation in the state of Texas' Opioid Litigation Settlement. Addison's allocation of the settlement will be approximately \$58,094 that can be used for expanded training and supplies for first responders, opioid-related treatment programs, and opioid prevention programs, among other things.


Economic Development Meet and Greets are Back

Hand Drawn Records Expands Operations






