Council Update

COVID-19 Vaccine Update



On Monday, May 10, the U.S. Food and Drug Administration (FDA) expanded the emergency use authorization for the Pfizer COVID-19 vaccine to include adolescents 12 through 15 years of age. Dallas County Public Health Director Dr. Philip Huang

encourages parents to pre-register their kids for the vaccine on the county website. Those 17 years old and younger must have parental approval to receive the shot.

On Thursday, May 13, the [CDC announced new COVID-19 guidelines](https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated-guidance.html) that essentially get rid of masks and social distancing for fully vaccinated people: <https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated-guidance.html>

Here are the highlights:

- Fully vaccinated people no longer need to wear a mask or physically distance in any setting, except where required by federal, state, local, tribal, or territorial laws, rules, and regulations, including local business and workplace guidance.
- Fully vaccinated people can refrain from testing following a known exposure unless they are residents or employees of a correctional or detention facility or a homeless shelter

Fully vaccinated people can now:

- Resume activities without wearing masks or physically distancing, except where required by federal, state, local, tribal, or territorial laws, rules, and regulations, including local business and workplace guidance
- Resume domestic travel and refrain from testing before or after travel or self-quarantine after travel
- Refrain from testing before leaving the United States for international travel (unless required by the destination) and refrain from self-quarantine after arriving back in the United States
- Refrain from testing following a known exposure, if asymptomatic, with some exceptions for specific settings
- Refrain from quarantine following a known exposure if asymptomatic
- Refrain from routine screening testing if feasible

For now, fully vaccinated people should continue to:

- Get tested if experiencing [COVID-19 symptoms](#)
- Follow CDC and health department travel requirements and recommendations

Council Canvasses May 1 Election Results and Swears In Newly Elected Members



At its May 11 meeting, the Addison City Council canvassed the results from the May 1 election. Mayor Chow was running unopposed so the Council approved a "Certification of Unopposed Mayoral Candidate" at its March 9 meeting which declared Mayor Chow elected as Mayor. Council Members Lori Ward and Tom Braun were each re-elected for an additional two-year term and Kathryn Wheeler was elected for her first term.

Upcoming Public Hearing



Addison Wants Your Input on the Sam's Club Study Community Open House Planned for June 10



At its April 27 meeting, the City Council approved a contract with Dallas-based urban planning and facilitation firm Strategic Community Solutions to complete the [Sam's Club](#)

Special Area Study that was initiated in 2014.

To begin the visioning process, Addison is asking residents who live and work around the study area to [fill out a survey](#).

The boundaries of the study are Belt Line Road to the north, Hornet Road to the south, Midway Road to the east, and the property lines between the Midway Road commercial properties and the residential neighborhoods to the west. The new Addison Grove development (on the former Sam's Club site) is included in the study area for reference, but the study will not change the direction for the development of this property – it will continue to follow its current zoning.

The Town will also be hosting several community open house events for Addison residents, property or business owners, stakeholders, or interested groups. The first is scheduled for Thursday, June 10 from 6 - 8pm at the Addison Athletic Club. There will be a brief presentation at 6pm, followed by informal discussions. Participants are welcome to come when they want and stay as long as they choose.

It's the time of Year to Prepare for Egret and Heron Control and Addison Needs Your Help

The Parks and Recreation Department is asking residents to help deter egrets and herons from forming nesting colonies (rookeries) in Addison. Urban rookeries can cause noise, odor, public health hazards, and damage to property. Residents can help by following these three simple steps:

1. Egrets and Herons like dense tree canopies and nest in trees that are 20' tall or greater. They like areas with contiguous canopy where large trees have grown together. You can be a big part of the solution by heavily thinning out the interior branches of your trees so they have 75% density or less. If possible, prune trees so they do not touch other trees. January and February is an ideal time to prune trees.
2. Familiarize yourself with what Egret and Herons native to our area look like.
3. If an Egret or Heron is beginning to build a nest in some cases the Parks and Recreation Department can deter the birds or remove the nest if eggs have not been laid. Please notify us if you think you have seen an Egret or Heron beginning

to build a nest by emailing Matt Ansted at mansted@addisontx.gov. It's helpful if you include in your email the location, a description of the bird, and a photo if possible. You can also report sightings on Addison's [FixIT app](#).

In some cases, we may be able to use hazing tactics to encourage them to leave. Herons and egrets are protected under the Migratory Bird Act, so please do not harm them, their nests, eggs, or hatchlings.

Oncor Completes Work On Redding Trail

The following week, the replacement rules signs will be installed and the project will be complete.
