WHERE FLG x FLG CONNECTIONS WOULD RESULT IN A CONFLICT WITH THE PROPOSED CURB, OR PROPOSED OR EXISTING UTILITIES, ANCHOR COUPLINGS AND A SPOOL PIECE SHALL BE INSTALLED FROM THE TEE OR CROSS TO THE VALVE TO ALLOW FOR ADJUSTMENT.
